

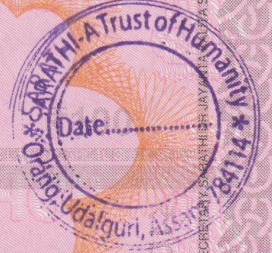

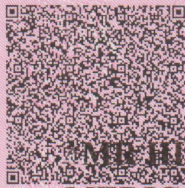
MEMORANDUM OF UNDERSTANDING (MoU)

This Memorandum of Understanding is made on this 05th day of July, 2026, by and between:
 SARATHI TRUST, a registered trust under the Indian Trusts Act, 1882, (Trust Reg. No. 2026/1GR086/4/34) having its registered office at Orangi, Udalguri, Assam - 784114, represented by its Secretary Dr Jayanta Kalita, hereinafter referred to as the "FIRST PARTY",

AND

LIFE WELL MEDICOS, a licensed pharmacy located at Orangi Pauripota Road, Orangi, Udalguri, Assam, represented by its Proprietor Mr Hitesh Choudhury, hereinafter referred to as the "SECOND PARTY".

Both parties shall collectively be referred to as the "PARTIES".

1. PURPOSE OF THE MoU:

Sarathi Trust is established for the welfare of poor meritorious students, specially abled children, and the underprivileged. To extend healthcare support to its members, the FIRST PARTY seeks collaboration with the SECOND PARTY for providing medicines at concessional rates.

2. SCOPE OF COLLABORATION:

The SECOND PARTY agrees to provide discounts on all allopathic medicines to the authorized members of the FIRST PARTY, subject to the following terms:

Discount Structure:

Life Members of Sarathi Trust: 12% discount on MRP on all medicines.

Donor Members of Sarathi Trust: 13% discount on MRP on all medicines.

Patron Members of Sarathi Trust: 14% discount on MRP on all medicines

3. TERMS & CONDITIONS

(a) **Eligibility:** The discount shall be applicable only upon production of a valid Membership Card/ID issued by Sarathi Trust with photograph and membership category clearly mentioned.

(b) **Verification:** The SECOND PARTY reserves the right to verify membership from the FIRST PARTY if required. The FIRST PARTY shall share an updated list of members time to time.

(c) **Exclusions:** The discount shall not apply to baby food, cosmetics, and medicines already under company-offered special pricing controlled drugs where discount is restricted by law.

(d) **Non-transferable:** The benefit is strictly for the members and cannot be transferred or misused.

(e) **Validity:** This MoU shall remain in force for a period of 3 years from the date of signing, i.e., from 5th July 2026 to 4th July 2029.

(f) **Renewal:** The MoU may be renewed or modified with mutual written consent of both PARTIES before expiry.

(g) **Termination:** Either PARTY may terminate this MoU by giving 30 days prior written notice to the other PARTY.

4. RESPONSIBILITIES OF THE PARTIES:

First Party – Sarathi Trust shall:

- (i) Issue tamper-proof ID cards to all categories of members.
- (ii) Inform its members about the terms of this MoU and prevent misuse.
- (iii) Acknowledge LIFE WELL MEDICOS as "Healthcare Partner" in its publications/events.

Second Party – Life Line Pharmacy shall:

- (i) Honor the agreed discount to all eligible members during business hours.
- (ii) Maintain proper records of discounted sales to Trust members for transparency.
- (iii) Display information about this collaboration at the pharmacy counter.

5. FINANCIAL IMPLICATIONS:

No financial consideration is involved between the PARTIES for this MoU. This is a welfare-oriented collaboration and neither party shall claim any charges from the other.

6. DISPUTE RESOLUTION:

Any dispute arising out of this MoU shall be resolved amicably through mutual discussion. If unresolved, the decision of the Secretary, Sarathi Trust and Proprietor, Life Well Medicos shall be final.

7. LEGAL JURISDICTION:

This MoU shall be governed by the laws of India and subject to the jurisdiction of courts at Udalguri, Assam.
